Minutes of Meeting of Executive Innovation Committee (EIC) and Internal Innovation Committee (IIC) to discuss about the Policy Documentation of LND College, National Innovation and Start-up.

<u>Preamble:</u> Subsequent upon the constitution of the expert level (EIC) and internal level committees- EIC and IIC towards the establishment of Institution's Innovation Council (IIC) unit and hence implementation of NIS Policy-2019, the meeting was organised on September 25, 2021. The objective of the meeting was- (a) To introduce the essence of the NISP-2019 before the committee members, (b) To brainstorm the session with the need, concept and ideology of the policy, and (c) To seek out the relevance of the innovation policy in the present context of LND College.

The meeting was attended by the nominated expert members and internal faculty members of the College (List is enclosed).

The record of the presentations and discussions held on this meeting is given below.

1. Welcome and Introduction by Dr. Sarvesh Dubey, Convenor & Coordinator, NISP (LND College, Motihari)

Dr. Sarvesh Dubey, convenor of the meeting, warmly welcomed all the members to the meeting arranged on Google meet (online mode). He introduced the members before the committees. He hoped that the gathering of the experts would result in some specific plans and opinions to help and support innovation in the college campus. He thanked the participants for agreeing to spare time from their busy schedules at a very short notice.

2. Brainstorming

Dr. Sarvesh Dubey, put the objective and agenda of the meeting before the committee members. Through power point presentation, he introduces the committee members with keys points of the NISP-2019 of Institution's Innovation Council of MoE. Moreover, Dr. Dubey talked about the potential points which must be part of the College NIS policy document.

3. Key Comments of Experts regarding the structure of the LNDC Innovation and Start-up Policy.

Dr. Pramod Kumar Tiwari, Associate Professor, Dept. of Electrical Engineering, IIT Patna and Convenor, Incubation and Start-up Activities at IIT Patna discussed about the various activities being run in the Incubation Center of IIT Patna. He promised that the Incubation Center of IIT Patna will extend their support to LND College in establishing the fruitful ecosystem of innovation and start-up activities in the college premises. Further, he advised to include some key points and regulations in the innovation policy of the college regarding the tradition knowledge of Champaran, Bihar under the Intellectual Property Rights (IPR) section. He added, the students should be made aware and trained about proliferation of new and constructive ideas. The college must run such awareness programmes among

students as well as faculty members. He coined the term- "the idea may be little, but outcome must be large". Moreover, Sri. Pandey promised to help in establishing an incubation centre at LND College in near future.

Dr. Kumar Shubham, Director, Double Click Solutions Pvt. Limited, Greater Noida, U.P., commented about the training about financial management among the aspirants. Further, he advocated the necessity for the workshops and policy about the marketing, branding platform, and capital arrangement in starting new ventures.

Prof. (Dr.) Satish Kumar Rai, HoD, University Dept. of Hindi and Director, Dept. of Journalism, B.R.A. Bihar University Muzaffarpur, gave his positive comments about IIC and hoped the new policy about innovations and entrepreneurship would encourage the self-employment among youths.
