### **Preamble:**

This Memorandum of Understanding (MOU) is entered into on this 1<sup>st</sup> day of November, 2021, between L.N.D. College, Motihari, and Khwab Foundation, for the purpose of collaborating on initiatives aimed at the training about soft skill and fostering the ethos of entrepreneurship among college students.

### **Background:**

L.N.D. College and Khwab Foundation in joint venture determined to train the college students about soft skills and development of culture of entrepreneurship as per the Laxmi Narain Dubey College-Innovation and Start-up Policy 2021. Both parties aim to join hands to provide students with comprehensive opportunities for skill enhancement, and personality development.

### **Objectives:**

1. To enhance the overall development of college students by offering programs that encompass academic, extracurricular, and personal growth aspects.
2. To create a collaborative framework for sharing resources, knowledge, and expertise to benefit the student community.
3. To provide students with platforms to develop essential life skills, leadership qualities, and social awareness.

### **Terms of Collaboration:**

1. Program Design and Implementation: The Foundation shall collaborate with the college to design and implement programs, workshops, seminars, and activities that align with the goal of all round development of college students.

2. **Skill Enhancement:** The Foundation shall provide expertise in areas such as communication skills, career development, and other relevant skills to empower students for their future endeavours.
3. **Mentorship and Guidance:** The Foundation shall facilitate mentorship opportunities, connecting college students with experienced professionals and experts in software development.
4. **Extracurricular Activities:** Both parties shall work together to organize extracurricular activities, cultural events, and community engagement initiatives that contribute to the overall growth of students.
5. **Resource Sharing:** The college and the Foundation shall exchange relevant resources, materials, and information to ensure the successful implementation of joint initiatives.
6. **Evaluation and Feedback:** Both parties shall conduct periodic assessments of the effectiveness of the collaborative programs and gather feedback from students to make improvements.

**Financial Arrangements:**

The financial responsibilities related to the collaboration shall be negotiated on a case-by-case basis for each program or initiative.

**Duration and Review:**

This MOU shall be effective from the date of its signing and shall remain in force for an initial period of three years. Either party may initiate a review of the MOU's implementation at any time, and amendments can be made by mutual agreement.

**Termination:**

This MOU may be terminated by either party with prior written notice of [Notice Period, e.g., 30 days] to the other party in case of substantial non-compliance with the terms mentioned herein.
